Interface

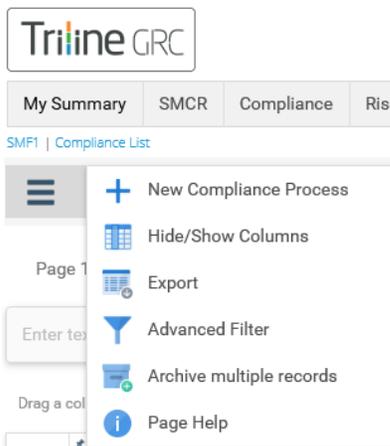
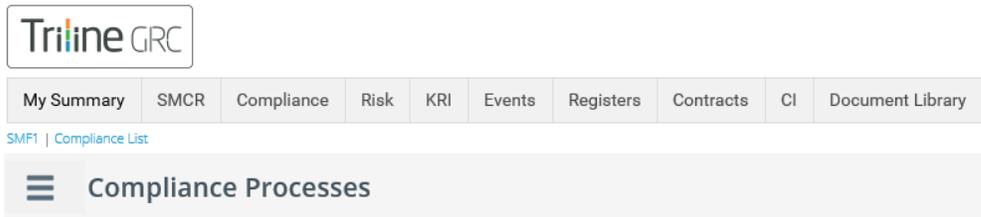
The first thing you will notice with this release is the new, contemporary interface.

Logging in

On the login page you can now press the Enter key instead of having to click the Login button.

Page menu replaces the button bar

On most screens there was a vertical button bar on the left side. This has been replaced by the 'hamburger' menu icon in the page header.



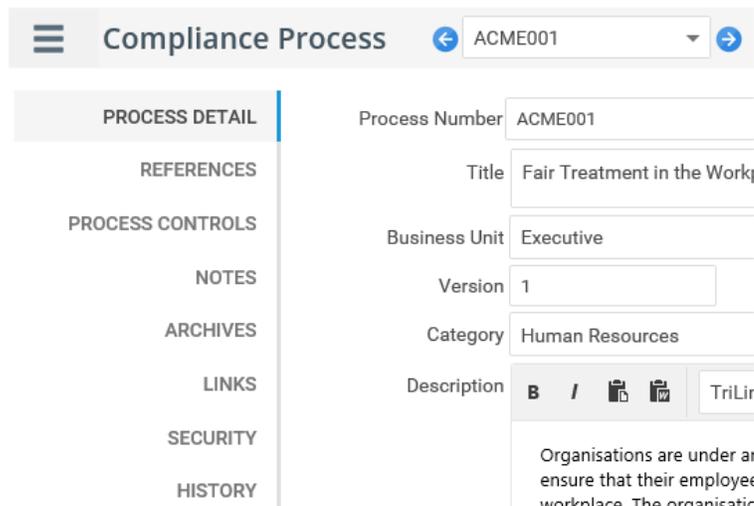
Simply mouse over the icon to display the menu (no need to click the icon).

Tabs

On some pages the tabs will now appear vertically rather than horizontally.

Logout

Using the Logout button is strongly recommended as it releases system resources for other users. The button has been changed to make it more obvious.



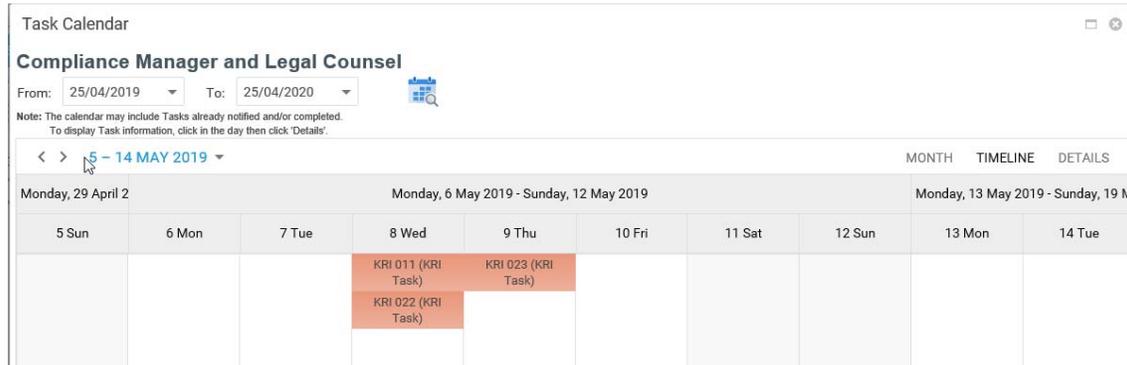

Calendar View of Tasks

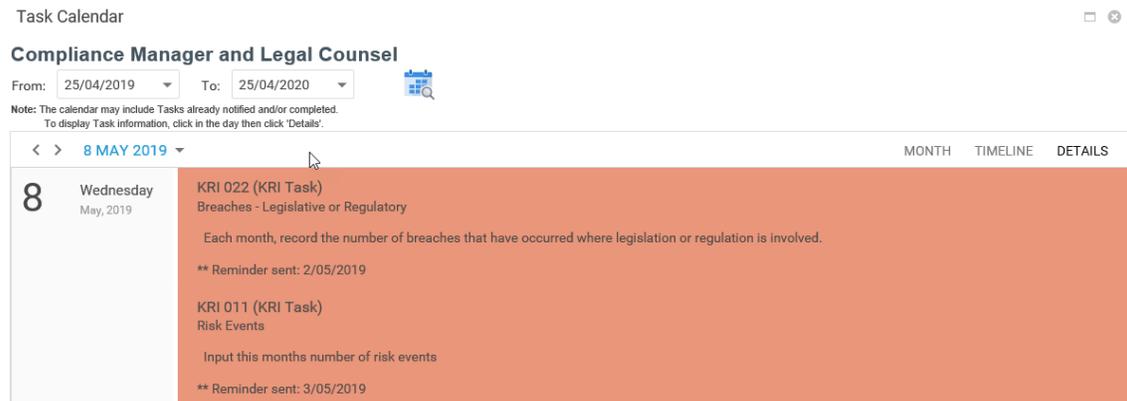
It is now possible to display a calendar view of Tasks.



Click the icon to the right of the Position selector on the My Summary page to display that Position's Tasks in a calendar view. The default view is a 'Timeline' for the next 12 months.



Click on 'Month' to display a view by Month. To display the details of each day, click on the day area and the click 'Details'.

Grid Context Menu

On the primary grid pages (e.g. List of Compliance Process records), right-click the header to display a context menu.

You can display the Column Chooser popup (instead of using the page menu), show or hide the Group Panel, Search Panel, Filter Row and Filter Row Menu.

For the column that you clicked you can 'hide' the column (e.g. move it to the Column Chooser) and Sort by that column.

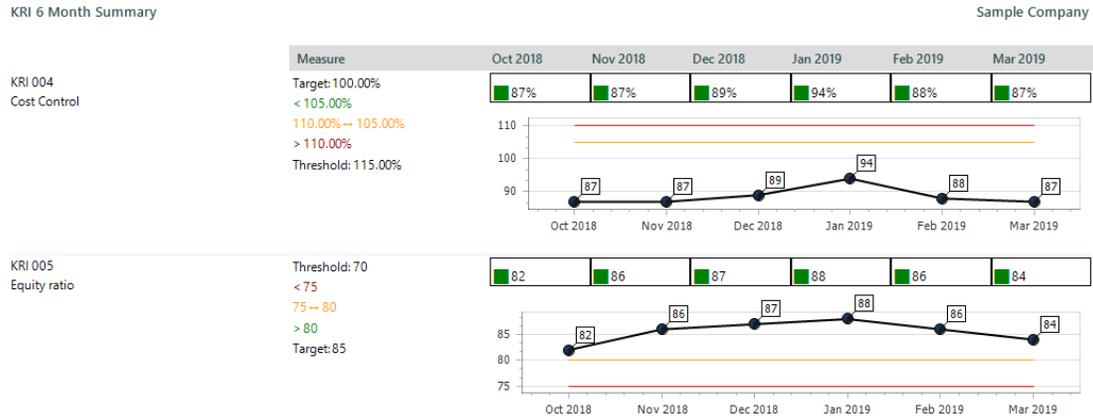

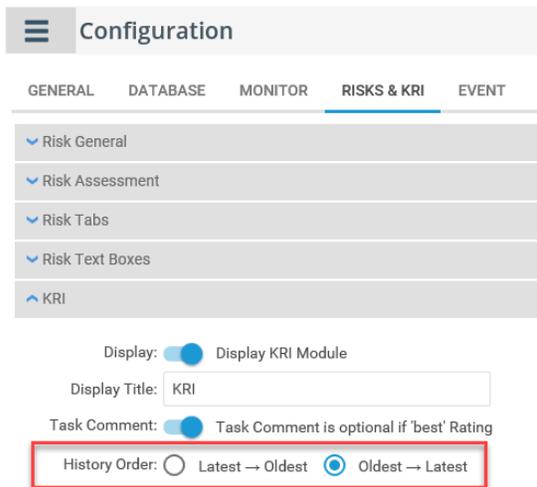

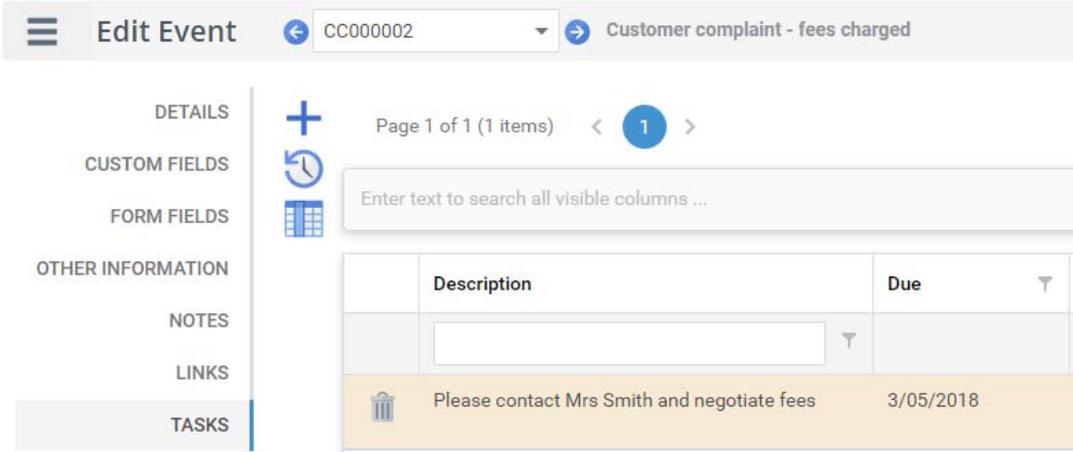

Existing Tasks

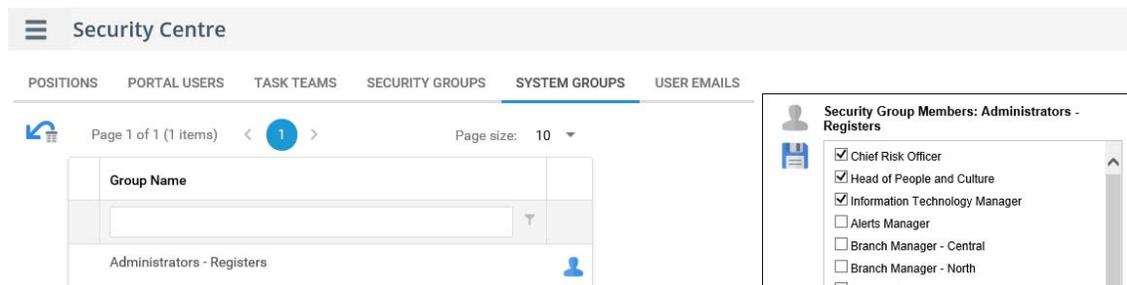
All existing Tasks, completed or otherwise, will have the Frequency set to AdHoc.

Selecting a Frequency

If a Task is not to occur on a cycle, the Frequency must be set to AdHoc. If a Position allocated to complete a Task is to be made Obsolete, any Tasks with a Frequency of AdHoc that have been completed, will not hinder the Position becoming Obsolete. The Position will not be able to be made Obsolete if the Frequency is other than AdHoc or and AdHoc Task has not been completed.

Administrator – Registers

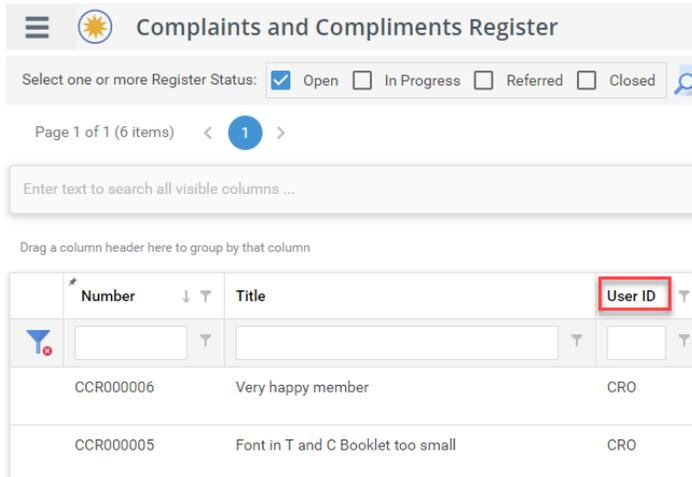
A new System Group (Administrator – Registers) has been added. Members of this group will have Administrator level security access to all Register Types and records.

The User ID of the Position that created the Register record is available as an optional column in all lists.

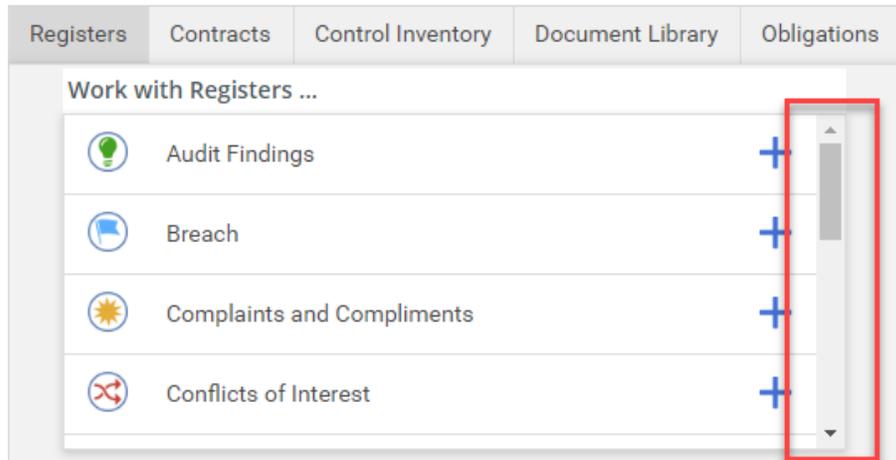
